### **Counter-Notification**

If you believe that your content has been removed or disabled in error, you may submit a counter-notification with the following information:

- Identification of the material that has been removed or to which access has been disabled and the location at which the material appeared before it was removed or disabled.
- Your contact information, including your name, mailing address, email address, and phone number.
- A statement by you, made under penalty of perjury, that you have a good faith belief that the material was removed or disabled as a result of a mistake or misidentification of the material.
- A statement by you that you consent to the jurisdiction of the federal court in which your address is located, or if your address is outside the United States, the jurisdiction of the federal court in your country

and that you will accept service of process from the person who provided the original copyright infringement notification or an agent of such person.

- Your physical or electronic signature.
- Please send your counter-notification to our designated Copyright Agent at the contact information provided above.

Upon receipt of a valid counter-notification, we will promptly restore access to the material, unless the copyright owner files a legal action against the alleged infringer and provides us with notice of such action.
